To fulfill our mission, SVP Boulder County works toward a respectful, welcoming, and inclusive culture striving to integrate diversity of thought, background, and experience; to practice transparency and respect; and to bring an equity and social justice lens to our organization and our work in the community.

PROGRAMS



This year, SVP continued to expand our program offerings to help strengthen Boulder County nonprofits. With the assistance of our Resource Teams, SVP Partners offered **2,870 hours** of volunteer time supporting **59 nonprofits** with **86 projects**.

We provided capacity building and monetary support to the four nonprofits engaged in our Catapult program: YWCA, LCJP, Impact on Education, and Wild Bear Nature Center. [See the full impact report here.](#)

We continued our steady work to become a more inclusive and equitable organization by revising our Catapult program, by creating our Culture Implementation plan through the amazing support of the Culture Working Group, and by our Partners who joined the anti-racism classes hosted by the YWCA.



WHERE WE ARE NOW



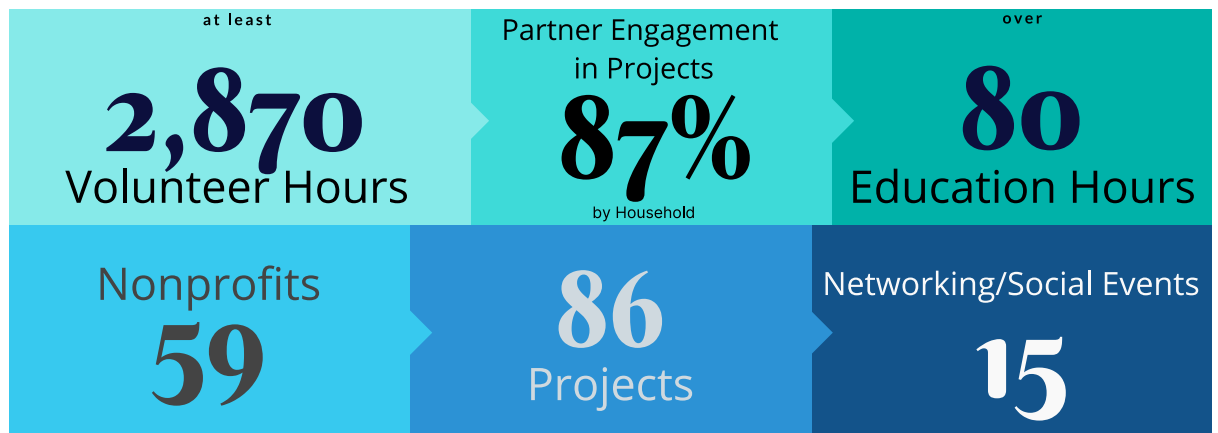

OUR CURRENT STATE



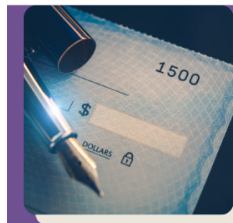

With careful monitoring of our financial picture, SVP maintained a strong financial position throughout 2021. While our Grants and Individual Donations were less than budgeted, our Earned Income, Corporate Donations and Board Fundraising were at or above expected. Additionally, throughout the year, SVP kept expenses low due to a difficult year globally and our PPP loan was forgiven during the fiscal year as well. Our resulting Net Income was positive by \$95,000. Moving forward, our challenge is to develop our revenue sources. We are in a very strong financial position as an organization moving into 2022.

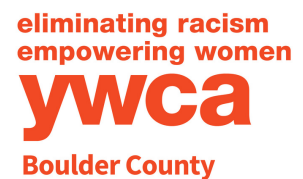
